#### I. CALL TO ORDER

Chair Velasquez called the meeting to order at 1:30 p.m.

#### II. PROCEDURAL ITEMS

A. Approval of Agenda and Additions to and Deletions from Agenda

Trustee Kunitzer motioned to amend the agenda to include an informal session to discuss personnel matters.

The agenda was unanimously APPROVED as revised.

B. Approval of Minutes February 19, 2017 Regular Formal Session of the Board of Control

It was moved and supported that the minutes of the February 19, 2017 Regular Formal Session be approved.

C. Recognition of the Official Representative of the Faculty Association

Professor Shaun Bangert, President of the Faculty Association, noted that this will be her last official meeting as President of the Faculty Association. She thanked Board members for making the past four years a great experience.

Chair Velasquez thanked Professor Bangert for doing a tremendous job and for representing this University and our faculty very well.

Over the past four years, President Bachand noted that Professor Bangert was always very professional and represented the Faculty Association with vigor and intensity. He thanked Professor Bangert for her dedication and service to our University.

#### D. Recognition of the Student Association

Cody McKay, President of the Student Association, announced that the Student Association recently worked with the Saginaw Transit Authority to negotiate the addition of "Nightline" — a late-night route from SVSU to Old Town Saginaw, with stops in between. He noted that the pilot program recently launched with significant interest from students and favorable feedback from riders and businesses alike. He indicated that the "Nightline" will run for three more weekends and it will include stops at movie theatres, restaurants, stores and more. He stated that if enough students take advantage of this opportunity, the Student Association hopes to make this a regular offering.

6. Resolution to Grant Undergraduate and Graduate Degrees

RES-2229 It was moved and supported that the following resolution be adopted:

WHEREAS, Saginaw Valley State University is granted the authority to confer undergraduate and graduate degrees as outlined in Section 5 of Public and Local Acts of Michigan 1965; and

WHEREAS, Operating Policy 3.101 Article III of the Board reserves to the Board the authority to grant degrees.

NOW, THEREFORE, BE IT RESOLVED, That the Board of Control of Saginaw Valley State University approves the awarding of undergraduate and graduate degrees at the May 5 and May 6, 2017 Commencement ceremonies as certified by the faculty and Registrar.

President Bachand noted that over 1,000 graduate and undergraduate students plan to participate in the Spring Commencement ceremonies.

The motion was APPROVED unanimously.

7. Resolution to Approve Appointment to the Marshall M. Fredericks Sculpture Museum Board (Samuel Tilmon)

RES-2230 It was moved and supported that the following resolution be adopted:

WHEREAS, The Marshall M. Fredericks Sculpture Museum Board is comprised of qualified individuals who have the responsibility of advising the President and the University Board of Control regarding major decisions of the Museum; and

WHEREAS, The Museum Board recommends that Samuel Tilmon be appointed to fill a two-year unexpired term of Odail Thorns. Mr. Tilmon's term will expire in April 2019.

NOW, THEREFORE, BE IT RESOLVED, That the appointed member serves on the Marshall M. Fredericks Sculpture Museum Board as stipulated in the organization's bylaws.

The motion was APPROVED unanimously.

8. Resolution to Approve Master of Science in Computer Science and Information Systems

RES-2231 It was moved and supported that the following resolution be adopted:

WHEREAS, the University Graduate Curriculum Committee has endorsed the Master of Science in Computer Science and Information Systems and the program will be ratified by the faculty on March 23, 2017; and

WHEREAS, according to the United States Bureau of Labor Statistics (BLS), 52% of all growth in STEM jobs between 2010 and 2020 will come from the Computing and Mathematics category, and according to the U.S. Department of Education, Master's

degrees have long been the fastest growing educational credential and computer science is the 8th most popular master's-level degree; and

WHEREAS, Great Lakes Bay Region Companies supported the need to offer access to advanced degrees in Computer Science and Information Systems that address the unique mix of technical and business related needs in the modern IT industries of the region; and

WHEREAS, there is a need for a Computer Science and Information Systems (MS-CSIS) interdisciplinary master's program with flexible course delivery for multiple learning styles, and hands-on skill-based curriculum for working professionals across multiple industries in region and the state;

NOW, THEREFORE, BE IT RESOLVED, THAT the Master of Computer Science and Information Systems (MS-CSIS) Program be approved for implementation in the Fall semester of the 2017-18 academic year; and

BE IT FURTHER RESOLVED, THAT the faculty in the College of Science, Engineering and Technology be commended for their timely response to the demand for an advanced degree in Computer Science and Information Systems in the region and throughout the state.

Provost Huntley noted that in developing the proposed program, SVSU faculty solicited feedback from auto companies such as Ford and Nexteer, as well other various other firms from Auto-Owners Insurance to Yeo and Yeo. She indicated that government agencies such as the U.S. Department of Defense also evaluated the proposal. She noted that all the reviewers indicated a growing demand for informational technology professionals with advanced degrees and they supported the proposed program.

Provost Huntley indicated that, if approved, SVSU will begin enrolling students for the new master's degree program immediately. She noted that the first courses would be offered this coming fall.

The motion was APPROVED unanimously.

9. Resolution Regarding Delegation of Contractual Authority

RES-2232 It was moved and supported that the following resolution be adopted:

WHEREAS, The Board of Control has ultimate responsibility for governing the University, which includes the power to delegate to others within the University authority to enter into legally enforceable contracts binding the University; and WHEREAS, The Board wishes to set forth clearly the procedures for delegating contract signing authority at the University and to replace RES-377, adopted April 10, 1978, and RES-692, adopted December 9, 1985; and to further ensure that the delegation of contract signing authority is consistent with BOC Bylaw 3.101;

NOW, THEREFORE, BE IT RESOLVED, That the Board hereby reserves to itself the authority to approve all contracts, subject to the delegation of contract signing authority as follows in order to facilitate the day-to-day administration and operation of the University:

- 1. The following Officers of the University, to wit: President, Executive Vice President for Administration and Business Affairs (Contracting Officer) and the Provost/Vice President for Academic Affairs are authorized to sign contracts binding the University in an amount not to exceed \$100,000 for any one contract.
- 2. The President and one of the above Officers, are authorized by their two signatures to sign contacts binding the University in an amount not to exceed \$250,000 for any one contract.
- 3. Any of the above named officers may, with the written authorization of the President, delegate authorization to other persons to sign contracts binding the University concerning non-monetary matters and for specified sums per contract not to exceed \$50,000. Such delegated contracting power shall be in writing, signed by the officer delegating authorization, naming the position given the contracting power, specifying the limitation in dollars, and stating the purposes for which contracts may be signed by the person given delegated power.

Copies of the written delegation of contracting power shall be placed on file in the Office of the Executive Vice President for Administration and Business Affairs.

The motion was APPROVED unanimously.

10. Resolution to Amend the SVSU Purchasing Policy

RES-2233 It was moved and supported that the following resolution be adopted:

WHEREAS, The University's Purchasing Policy was adopted by the Board of Control May, 1983 and amended May, 2004; and

WHEREAS, The revised Purchasing Policy updates operational practices and adjusts various transaction dollar thresholds to contemporary dollar limits;

NOW, THEREFORE BE IT RESOLVED, That the attached revised Purchasing Policy is approved.

The motion was APPROVED unanimously.

- 11. Motion to Establish the Board of Control Meeting Schedule for Academic Year 2017-2018

# Carolyn Wierda

# Executive Director of STEM • March Staff Member of the Month

Before volunteers signed up for the FIRST Robotics statewide competition at SVSU, Carolyn Wierda had a decision to make: How many T-shirts to order for those anticipated helpers.

Wierda ordered 400, thinking there was a good chance she would have a surplus of 100 after the event. Instead, she came up 25 shirts shy.

"We were hoping for 300 volunteers," said Wierda, who served as the volunteer coordinator for the FIRST Robotics event. "So having 425 people offer their help was a remarkable statement made by our students, staff and faculty."

What added to the remarkable nature of FIRST Robotics was the short amount of time Wierda was afforded to organize a large-scale volunteer effort for an event that was expected to — and did — bring more than 7,000 visitors from across the state to the Ryder Center. "I'm not sure we've ever had a volunteer effort of that magnitude," she said. "It was a challenge, and people stepped up."

The outpouring of support was a testament to one of SVSU's defining characteristics: its hospitality. "The people who visited were able to see how beautiful our campus is, how modern our facilities are, and how welcoming we are," Wierda said. "This event brought together people to an event that really emphasized what we have to offer."

Outside of those personable offerings, FIRST Robotics

also helped highlight another SVSU strength Wierda understands well: its STEM programs. High school students and parents were exposed to the university's faculty and students, along with the many STEM-based programs at SVSU.

Wierda has served as executive director of STEM since January 2015. Since then, she has worked to build upon — and market — the STEM programs already available at the university. Those initiatives extend beyond courses and classrooms for undergraduates, and include initiatives geared toward improving K-12 student interest in the sciences.

Wierda was quick to share credit for the development of SVSU's STEM opportunities with campus leaders, faculty, staff, students and regional partners. "There are so many people here and in our community who are doing tremendous things for STEM," she said. "With the relationships SVSU has with local businesses and the Great Lakes Bay Regional Alliance, there are many more opportunities that could come our way. There are a lot of people who are helping to make this happen."

Wierda also serves on Gov. Rick Snyder's STEM Advisory Council.

"That has brought a number of opportunities for our university," she said. "We're really doing everything we can to improve STEM education in the state of Michigan."



# Sue Brasseur

# Director of the Conference Center at SVSU • April Staff Member of the Month

Sue Brasseur did not have the luxury of Tinkerbell pixie dust when helping organize the FIRST Robotics statewide competition in April, but that didn't stop her from helping a show earn magical reviews.

At least one of the 7,000-plus visitors during the four-day Robotics event compared SVSU's hospitality to a "Disney-like" experience. Plenty more compliments poured in to the campus following the contest, but the Disney analogy was the most touching and flattering compliment for Brasseur, who has strived for such excellence since attending a Disney workshop on hospitality.

"I wanted to make sure FIRST Robotics was the best experience for these first-time guests, and that the university would shine," she said. "To bring all these people onto campus and have it fail ... that was not something I was going to settle for. To have a 'Disney-like' experience means you are going above and beyond the expectations of someone. They were expecting 'A,' you gave them 'A,' and then you also gave them 'B, C and D' and so on."

The accomplishment was especially satisfying considering the degree of difficulty involved. Hosting an event the size of FIRST Robotics ideally involves two years of preparation time and planning, she said. SVSU had 17 weeks to gear up for the gathering after organizers committed to the venue. The difficulty of that quick turnaround was compounded by the fact that FIRST

Robotics represented what Brasseur considered the most complex event planning operation in university history.

"Bigger than the Lions," said Brasseur, referring to the Detroit NFL franchise that hosted its training camps at SVSU's campus in the late 1990s and early 2000s.

Along with other FIRST Robotics' organizers, Brasseur helped coordinate accommodations for 160 high school teams that competed and appearances by high-profile guests such as Gov. Rick Snyder and U.S. Senator Gary Peters.

Tackling all those elements involved many people working massive amounts of hours during the days and weeks leading up to the event. During the four days of setup and four days of the event, Brasseur logged 125 hours of work. There are 192 hours in an 8-day span.

"It was a lot of work, but you just do what you've got to do," she said. Brasseur said the effort involved coordination between several branches of the university. "Things like this can't happen without a team environment," she said. "My team at The Conference Center at SVSU is exceptional. All the departments and offices that helped make this happen were exceptional."

And they might need to pull it off again, albeit next time with much more advance notice. Brasseur said the university is already in discussions with FIRST Robotics to return next year.

Karen Erwin, administrative assistant to the dean of students, has an office located in the Student Affairs suite. The team in this suite — Erwin included — carry many responsibilities, largely helping the many students who find their way into the office.
