Chair Velasquez called the meeting to order at 1:35 p.m.

WHEREAS, In 2018, SVSU students raised \$36,210 for this year's charity partner, the Saginaw-based Barb Smith Suicide Resource and Response Network, which will use the funds to expand its suicide awareness training sessions in the community and at higher education institutions across the state; and

WHEREAS, for the eleventh consecutive year, SVSU has won the week-long Battle of the Valleys fundraising competition with Grand Valley State University; and

WHEREAS, over the 15-year history of Battle of the Valleys, SVSU students have now supported community causes with a combined \$425,657 in donations; and

WHEREAS, in total, the two universities have collected \$652,385 since 2003;

NOW, THEREFORE, BE IT RESOLVED, That the Board of Control of Saginaw Valley State University congratulate the 2018 Student Association and through them, the entire student body which they represent, for a successful and commendable fundraising effort and for continuing a spirit of generosity and philanthropy on this campus and in the Great Lakes Bay Region.

Chair Velasquez and President Bachand expressed their appreciation to the Student Association for their outstanding effort and tremendous leadership in this year's "Battle of the Valleys" fundraising competition.

President Bachand commented that nearly 556 students are expected to participate in the December 2018 Commencement ceremonies.

President Bachand noted that this includes the awarding of an honorary posthumous degree to Joseph DuCharme who was a student in the College of Science, Engineering and Technology. Mr. DuCharme was near completion of his Mechanical Engineering degree and was in excellent academic standing, having obtained a GPA of 3.55.

The campus community grieves the loss of Mr. Joseph DuCharme, stated President Bachand, and the university expresses sympathy and compassion to his family and friends.

The motion was APPROVED unanimously.

6. Resolution to Approve Confirmation of Board Members for Previously Authorized Public School Academies

Dr. Deborah Huntley \$ 234,600 (deferred compensation - \$15,000) Mr. James G. Muladore \$ 224,000 (deferred compensation - \$15,000)

NOW, THEREFORE, BE IT RESOLVED, That the Board of Control of Saginaw Valley State University award the maximum amount of deferred compensation (\$25,000) to the President in accordance with the President's employment contract dated January 1, 2016.

Director of Student Wellness Programs • October Staff Member of the Month

Keeping the living healthy and nourished comes natural for Andrea Hamlin.

At the age of 8, the SVSU alumna began tending to the greenhouse used for her mother's business in Oscoda. It was Hamlin's responsibility to make sure the flowers blossomed to their full potential. That same desire to watch those gardens thrive now also applies to the students whose health and wellness she oversees.

As director of Student Wellness Programs, Hamlin coordinates educational and fitness-geared programming that aim to strengthen participants' mental and physical health. As part of her responsibilities, she coordinates education programs relating to sexual assault prevention. She leads a team of 25 volunteers, 15 student employees, 15 fitness instructors and five personal trainers.

"There's a lot of communication going on, but there are a lot of people who are supporting me," Hamlin said of those she leads as well as her mentors including Sidney Childs, the associate provost for Student Affairs and dean of students, and Josh Ode, the associate vice president for Academic Affairs who led many of her exercise science-related classes when he was a faculty member and she was an undergraduate.

Around the time she was still caring for her mother's flowers, Hamlin envisioned herself in a different profession. She wanted to become a meteorologist. She remained on the path to such a job when she arrived as a student at SVSU. But, partway through

her undergraduate experience, she was inspired by a classmate suffering from Stage IV Hodgkin's lymphoma.

"He had promised himself that he would exercise regularly and eat healthy while going through chemotherapy," Hamlin said. "He knew the importance of being as healthy as possible while he was going through that. Seeing his dedication to that had a huge impact on me."

Her classmate went into cancer remission — he remains healthy to this day — and she chose exercise science as her academic major shortly thereafter.

After earning her bachelor's degree in 2010, Hamlin worked as a personal trainer in Midland for one year before accepting a job at SVSU overseeing fitness programs. She later earned a master's degree in sports administration and moved into her current role as Student Wellness Programs director.

While she began managing the health of humans, she never lost interest in the life she first cared for as a child: flowers. Five years ago, Hamlin began selling her garden-grown flowers alongside her Saginaw Township home. That hobby blossomed into a growing enterprise — now called Andie's Arrangements — that includes providing flowers for weddings, baby showers and other large events. She recently purchased two acres of land specifically to expand her garden.

"They say, 'If you enjoy something, it's not work,'" Hamlin said. "I'm enjoying what I'm doing."

Brooke Murray speaks highly of the love she has for her job, her student employees and SVSU. She puts forth that care into every event that her catering and concessions office hosts.

As the catering and concessions manager, she is in charge of both the catering for events held on campus and the concessions sold during athletic events. Murray's compassionate attitude and work ethic prepares her for these various events.

"I consider myself kind of like a professional party-crasher," she said. "I am the eyes and ears of the parties that happen. I make sure that people get what they need before they even know they need it.

"With concessions, it's more about keeping up with that same game day energy. It's a pretty cool juxtaposition of the two jobs. Sometimes I'm handling someone's dream wedding day, and sometimes it's game day with hot dogs and brats."

Whether they are providing concessions for football games or catering high school proms and wedding days, Murray and her staff show their Cardinal pride by demonstrating her personal motto that she tells to all of her student employees.

"I always tell them, 'I want you to think of everyone you're taking care of like your grandma.' How would you want your grandma to be treated?" Murray said.

Murray puts her heart into everything she does, including going out of her way to make her customers' days better.

"For me, it's really important to be in a position where I can help people," she said. "I try to do little behind-the-scenes things that hopefully no one realizes is being done to help someone have a better day."

Not only does she give all of her customers the best possible experience at their events, she always wants to make sure that her student employees feel at home as well.

"I love my students more than anything," she said. "Sometimes I am like their surrogate sister figure or mother figure. It is really important for me to make sure that they are comfortable, happy and content."

When speaking about what SVSU means to her, Murray's excitement and love for the university shines brightly.

"I think that we're home. We're home to the people who have parties, and we're home for our students," she said. "I really like to get students as freshmen and sophomores and watch them grow and graduate and move on.

"We form a really big family, and I think that's more than just in my department, that's university wide."

Like the printing presses that continue churning out material for SVSU in her office, Angela Bublitz keeps adding pages to her story at the university.

Growing up in Bay City, she enrolled as an undergraduate in the 2000s, receiving a bachelor's degree in professional & technical writing in 2007.

During her last semester as a student, Bublitz earned an internship working in the Graphics Center. Since then, she has never looked back; she has only moved forward.

After receiving a full-time job there as assistant manager in 2007, Bublitz became the Graphics Center manager in 2016. It's a story she is happy to continue.

"I just like the whole culture of SVSU," Bublitz said. "I enjoy being here."

The Graphics Center is represented in a multitude of ways across the university.

From marketing materials for the Admissions office to flyers advertising events in the Performing Arts Center, the work flying off the presses in Bublitz's office can be found in all corners of campus. It's a labor of love for her.

"There isn't a typical day, which is one of the best parts," she said. "It's not just the printing. We need to do all of the finishing work — like cutting, folding and binding.

"We try to schedule all of that stuff out in the day as efficiently as possible so that everything gets done on time."

The office produces hundreds of jobs each month, some large and some smaller. The size of the job does not always mean simpler work, however.

"It's the smaller jobs that can throw a wrench in things," she said.

"The ones that you do all the time — the ones that repeat — you know what you're doing. It's the little ones — where you need 50 of this invitation or 25 of this little greeting card — but it still needs to be printed and cut out, scored and folded." she said.

"It's the same set up, whether we're doing 1,000 cards or five." With jobs being submitted from everywhere on campus,

Bublitz enjoys working with her office's clients in order to get these jobs done.

"I just want to do the best of my ability and help them get their jobs done to the best of their ability," she said. "Nobody is on an island around here. Everybody's got to work together, everybody's got their part to make things work and to get things done for the students.

"That's the whole point of being here."
