I. CALL TO ORDER

Chair Velasquez called the meeting to order at 1:30 p.m.

II. PROCEDURAL ITEMS

A. Approval of Agenda and Additions to and Deletions from Agenda

B. Approval of the December 14, 2018 Minutes for the Regular Formal Session of the Board of Control

C. Recognition of the Official Representative of the Faculty Association

Dr. Deborah Bishop, President of the Faculty Association, commented on a resolution before the Board recommending tenure to ten SVSU faculty members. According to the American Association of University Professors, Professor Bishop noted: "The principal purpose of tenure is to safeguard academic freedom...free inquiry, free expression, and open dissent are critical for student learning and the advancement of knowledge. Therefore, it is important to have systems in place to protect academic freedom. Tenure serves that purpose."

Professor Bishop stated that she is pleased to welcome the individuals who are being recommended for tenure.

D. Recognition of the Official Representative of the Student Association

Caitlin Coulter, President of the Student Association, commented that the 4th Annual Cardinal Ball is scheduled to take place on Friday, February 22nd. She also noted that the Student Association election season is underway. She stated that election results will be announced on April 4th.

Ms. Coulter thanked the Board and Administration for a great year and for all their support throughout the past year.

Chair Velasquez thanked Ms. Coulter for her report and commended her for representing our student body so well.

Event & Theatre Technology Specialist • January Staff Member of the Month

It's not often Andy Sharrow finds himself front and center in the spotlight. Usually, he's the one responsible for casting the light on others

But SVSU's event & theatre technology specialist said he was pleasantly surprised recently when he learned he was named the January Staff Member of the Month. For much of his experience at SVSU, after all, he has worked behind the scenes. His role managing the audio and visual technology — used for campus events ranging from concerts to commencement — many times goes unrecognized by audiences captivated by the result of his hard work rather than by the source of it.

Sharrow does not mind the lack of attention as long as he knows his behind-the-scenes team — which includes one other full-time staff member and seven student employees — continues to perform its job well, he said. His approach to the work dates back to his days as a Bay City Central High School student operating lightboard and soundboard equipment for the school's theatre productions.

He continued in that role when he enrolled at SVSU as an undergraduate in 2003. Even then, despite the behind-the-scenes nature of the work, Sharrow earned praise for his dedication and skill. After programming computer-animated graphics used during an SVSU production of "A Christmas Carol," a review from The Saginaw News noted how his work seemed "almost like another character" in the play.

"It's a big thing when a reviewer notes your work like that," he said.

Sharrow graduated in 2008 with a bachelor's degree in theatre. He worked in technology at both The Dow Event Center as well as Horizons Conference Center before SVSU hired the alumnus in 2012 in the role he maintains to this day.

"It's the variety of work I enjoy most about my job," he said. "I was working on the Great Lakes Bay Regional Martin Luther King Jr. Celebration one day, then a health care conference on another day. In a few days, I'll be helping out with an event about support animals."

Once any particular event is under way, Sharrow's work sometimes consists entirely of standing by and making sure the production runs smoothly. As a result, he often becomes an audience member to musical performances in genres he would not typically favor and professional seminars in subjects he does not follow.

"It can be educational and entertaining," Sharrow said of his work. "Listening to a musical performance — there are definitely worse ways to spend an evening."

Sharrow said one of the favorite elements of his job involves forming relationships with the university's faculty, staff and students.

"We've worked hard on building bridges to other departments, because we work with so many of them," he said. "It's a great job."



Ryan Persails

Police Officer • February Staff Member of the Month

It was the kind of call Ryan Persails dreaded hearing on his police vehicle radio, but in the early morning hours of Jan. 22, that call came: A fellow law enforcer was shot.

Persails, a police officer with SVSU's University Police since 2010, was the first person to respond to the call for help from Saginaw Township Police Officer Jeff Koenig, who was shot in the jaw and shoulder during a traffic stop in nearby Saginaw Township.

Koenig survived the shooting and a suspect was apprehended hours later, but when Persails first heard the troubling dispatch at 2 a.m., all bets were off.

"In my mind, as I'm driving there, I'm thinking, 'Is this going to be an ambush?'" Persails said. "I was expecting the worst at first, but by the time I got there, I forgot all that. I was focused on helping Officer Koenig."

Within moments of Persails' arrival, Saginaw Township Det. Greg Remer pulled up to the scene. They helped their injured colleague into the back of Remer's vehicle before it sped toward Covenant HealthCare in Saginaw.

"You could tell Jeff was in pain, but it was a good sign that he was talking," Persails said of Koenig, who had called in his own shooting to Central Dispatch earlier. "We just wanted to make sure he was calm while we were getting him to the hospital."

When they arrived at Covenant, Koenig was listed in critical condition at first. He was upgraded to stable condition and released to recover at home over the course of the next few weeks.

The experience was humbling for Persails, who enjoys a tight-knit relationship with his University Police colleagues as well as peers in the law enforcement agencies patrolling the region surrounding SVSU. The agencies often collaborate and network resources, and he knew Koenig long before Jan. 22. Persails' close relationship with his peers as well as his close proximity to the dangerous incident — at the time of the shooting, he was patrolling an area less than five miles away — put things into perspective for him.

"It really opens your eyes to the kind of danger you can find yourself in as a police officer," Persails said. "Ninety-nine percent of the people we run into are good people, but there's always that danger."

The experience was eye-opening in other ways, he said.

"Everyone really came together to help, from the doctor and nurses who helped Jeff to all the businesses and people who have put together fundraisers to help him with expenses," he said. "It's been great, the way the community has responded to this. It's good to know police here have that kind of support."
