#### I. CALL TO ORDER

Chair Kunitzer called the meeting to order at 2:00 p.m.

Chair Kunitzer noted that the special formal session of the SVSU Board of Control is being conducted via video conferencing. He stated that "Due to the unique situation and unprecedented times we find ourselves in today, we will consider today's virtual meeting to be a Regular Formal Session of the Board of Control pursuant to Article II, Section 2.100 of our SVSU board bylaws." Chair Kunitzer stated if there are no objections, let's proceed. There were no objections.

Chair Kunitzer asked the Board Secretary to take a Roll Call to ensure a quorum. Secretary Kowaleski conducted a roll call of the Trustees and noted that a quorum was met with all Trustees being present.

#### II. ACTION ITEMS

1. Resolution to Approve the SVSU Faculty Association Collective Bargaining Agreement

RES-2373 It was moved and supported that the following resolution be adopted:

WHEREAS, Representatives of the University and the SVSU Faculty Association reached a tentative agreement to replace the 2017-2020 agreement between the University and the Association on November 9, 2020; and

WHEREAS, The SVSU Faculty Association ratified the tentative agreement on November 19, 2020;

NOW, THEREFORE, BE IT RESOLVED, That the Board of Control does hereby approve the collective bargaining agreement between Saginaw Valley State University and the SVSU Faculty Association covering the period from July 1, 2020 through June 30, 2023.

Ellen Crane, University General Counsel, commented that the proposed collective bargaining agreement is a three-year contract and it was ratified by the faculty association membership November 19, 2020.

Ms. Crane further explained that the terms of the agreement call for SVSU faculty members to each receive a \$1,500 lump sum payment for the current fiscal year, and wage increases of 2% for the second year of the contract and 1.9% for the third year of the contract. She noted that the agreement also includes modest increases to the university's contribution for members' health insurance coverage.

Ms. Crane stated that the new collective bargaining agreement would be retroactive to July 1 of this year and it would extend through June 30, 2023.

Trustee Rupp commended the faculty for the excellent job they have done adapting to the recent pandemic environment. She offered thanks to the faculty association and the administration for their outstanding collaborative efforts throughout this process.

Chair Kunitzer expressed his appreciation to everyone involved in the bargaining agreement process for their great work solidifying a successful agreement.

The motion was APPROVED unanimously.
